Approve Award of Prime Bid Package Nos. 3, 5, and 9 to Various Contractors for the Modernization/Renovation of Harborside, Karl H. Kellogg, and John J. Montgomery Elementary Schools in the Amount of \$2,017,380

BACKGROUND INFORMATION:

In November 2012, local voters in School Facilities Improvement District (SFID) No. 1 approved Proposition E, a \$90 million general obligation bond to provide funds to renovate and modernize facilities and improve technology at thirty-one of the Chula Vista Elementary School District's (District) oldest schools, which are located mostly in the western portion of the District. Modernization priority was placed on the oldest eleven school sites: Ella B. Allen (Allen), Castle Park, Mae L. Feaster Charter, Harborside, Hilltop Drive, Karl H. Kellogg (Kellogg), John J. Montgomery (Montgomery), Lillian J. Rice (Rice), Rosebank, Sunnyside, and Vista Square Elementary Schools.

On June 13, 2013, the Board approved contracts with Balfour Beatty Construction (BBC) for construction management, and Ruhnau Clarke (formerly Ruhnau Ruhnau Clarke) for architectural engineering services for Proposition E general obligation bond projects (Proposition E Projects).

During 2012-2014, the District installed wireless technology equipment in all classrooms at all thirty-one school sites. During the summer of 2014, Castle Park, Rice, and Rosebank Elementary Schools were modernized and during the summer of 2015, Allen, Hilltop Drive, and Vista Square Elementary Schools were modernized. The District is now ready to proceed with Proposition E Projects scheduled for summer 2018, which include the modernization/renovation of Harborside, Kellogg, and Montgomery Elementary Schools. Accordingly, on December 1 and December 8, 2017, fourteen prime bid packages were published and noticed seeking bids. Bids were opened on January 11 and January 18, 2018.

Prior to the bid, it was determined the award of the contract would be based on the following method of determining the lowest bid: the lowest bid shall be the lowest bid price on the base contract without consideration of the prices on the additive or deductive items. In each case, the lowest responsive, responsible bidder was determined based on the base bid, for comparative purposes.

March 7, 2018 As noted in the applicable Project Labor Agreement (PLA), the District seeks to improve local labor participation and improve the number of bids for its projects. However, Section 4.3(a) of the PLA provides that "... in the event the District does not receive bona fide bids on otherwise covered work on or before the deadline for receiving such bids from at least three (3) responsible contractors, or the lowest responsive and responsible bid on a covered project is in excess of ten percent (10%) of the engineer's estimate, the District reserves the right to reject all bids and re-advertise the project with or without the application of this PLA."

At the February 14, 2018, Board meeting, the District awarded Prime Bid Package Nos. 1, 2, 4, 6-8, and 10-14, and rejected Prime Bid Package Nos. 3 (Concrete), 5 (Rough Carpentry), and 9 (Glass & Glazing). Bid Package Nos. 3, 5, and 9 were re-advertised, re-bid, and subsequently opened on February 15, 2018, without the application of the PLA pursuant to Section 4.3(a) of the PLA. Bid Package Nos. 3, 5, and 9 are being recommended by District staff for award based on review of the bids, pricing, and other factors. The overall savings on the rebidding of Prime Bid Package Nos. 3, 5, and 9 is \$952,258 or 13.5%.

Work on the Proposition E Projects will commence approximately June 4, 2018, with an estimated completion date of August 30, 2018.

ADDITIONAL DATA:

Recommended bid awards are attached as Exhibit "A". Bid documents are available for review in the Office of the Deputy Superintendent. In the event that a Prime Bid is withdrawn by the respective contractor, the next lowest bid will be substituted.

FISCAL IMPACT/FUNDING SOURCE:

Funding will be provided from Proposition E General Obligation Bond and other Capital Funds.

STAFF RECOMMENDATION:

Recommend approval of Prime Bid Package Nos. 3, 5, and 9.
